SUPER SPEEDER NOTICE

Pursuant to OCGA § 40-6-189, **any driver who is convicted of driving at a speed of 85 miles per hour or more on any road or highway or 75 miles per hour or more on any two-lane road or highway, is deemed a “super speeder” under Georgia law and will be fined an additional \$200 by the State of Georgia.** This fine is collected by the Georgia Department of Driver Services (“DDS”) and is in addition to any fine assessed by the county. This is not a county fine and has nothing to do with the court. The fine is triggered by the transmission of a conviction for a subject offense by the court to DDS.
